OBC COMMITTEE

The **OBC Committee** at *Malla Reddy Vishwavidyapeeth (Deemed to be University)* is constituted in accordance with:

- **UGC Guidelines for Establishment of OBC Cell in Universities/Colleges (2011),**
- **Reservation Policy of Government of India for OBC students in Higher Education,**
- **Constitutional Provisions – Articles 15(4), 16(4), and 46,**
- **MoE/UGC Notifications on OBC Reservation and Support Measures.**

The committee is entrusted with safeguarding the **interests of OBC students, faculty, and staff**, ensuring **equity, access, opportunity, and inclusivity** in all academic and administrative matters.

Objectives:

1. To implement the policies and programs of the Government of India related to OBC welfare in higher education.
2. To ensure proper implementation of **reservation policies** in admissions, recruitment, scholarships, and fellowships.
3. To monitor grievances of OBC students and employees and provide redressal.
4. To spread awareness among OBC students about government schemes, fellowships, and support facilities.
5. To prevent discrimination and promote equality among students and staff.
6. To recommend welfare measures for socio-economic and academic development of OBC students.

Roles & Responsibilities:

1. **Policy Implementation**
 - Ensure compliance with **Government of India Reservation Policy (27% reservation for OBC in central higher educational institutions).**
 - Monitor admissions, recruitment, and promotions for OBC reservation adherence.
2. **Grievance Redressal**
 - Receive and address grievances of OBC students and staff.
 - Recommend corrective measures to concerned authorities.
 - Maintain strict confidentiality of grievance proceedings.

- Submit periodic reports to the Vice-Chancellor and UGC/MoE.
- Suggest institutional welfare measures for OBC communities.
