- The Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989,
- UGC Notification F.1-7/2011(SCT), dated 31st January 2011, and
- Other relevant MoE/UGC circulars.

The committee ensures effective implementation of reservation policies, welfare schemes, and protection of rights of SC/ST students and employees, thereby promoting an inclusive and equitable learning environment.

#### **Objectives:**

- To safeguard the rights and dignity of SC/ST students, faculty, and staff within the University.
- 2. To implement and monitor UGC/MoE/GoI regulations regarding admissions, scholarships, fellowships, and reservation in services.
- 3. To create awareness about government schemes and welfare measures for SC/ST communities.
- 4. To provide support and guidance for academic, career, and personal development of SC/ST students.
- 5. To address and redress grievances of SC/ST students, faculty, and staff.
- 6. To prevent discrimination, atrocities, or unfair treatment on grounds of caste.

### Roles & Responsibilities:

#### 1. Policy Implementation

- Ensure implementation of UGC/GoI reservation policies in admission, appointments, promotions, and other benefits.
- Facilitate access to scholarships, fellowships (e.g., Rajiv Gandhi National Fellowship for SC/ST), and remedial coaching programs.

- o Ensure a caste-discrimination-free campus.
- o Promote cultural harmony, dignity, and respect for diversity.
