  - Facilitate access to government schemes, scholarships (e.g., Maulana Azad Fellowship, Post-Matric & Merit-cum-Means Scholarships).
2. **Grievance Redressal**
  - Receive and resolve grievances of minority students and employees.
  - Recommend remedial measures to prevent recurrence of issues.
