This Notification is issued for registration of the The students admitted by Malla Reddy Vishwavidyapeeth during the academic year (2025-26) to appear for **Fellowship in Palliative Care Nursing (2025-26 Batch) University Examinations** scheduled for February 02, 2026.

#### Eligibility:

1. The student's eligibility for the university exam requires a minimum of 80% attendance in theory and practicals respectively.
2. The student must have secured a minimum of 50% marks in the internal examination (theory and practicals respectively) of that Fellowship program.
3. Candidates must have completed the full duration of the Fellowship program.
4. Candidates must have completed all clinical postings, case records, and Log book duly certified by the Supervisor & Head of Department
5. Candidates must have obtained no dues from the institution
6. No candidate will be permitted without fulfilling eligibility conditions.
7. The Cut-off date for the calculation of the attendance percentage and internal assessment marks of the candidates is **21.01.2026**.
8. The uploading of the attendance percentage and internal assessment marks of the candidates is **23.01.2026**.
9. The confirmation date for the uploaded attendance percentage and internal assessment marks of the candidates is **24.01.2026**.

#### General Instructions:

10. Candidates must carry a valid hall ticket.
11. Use of mobile phones or electronic gadgets is strictly prohibited.
12. Any form of malpractice or misconduct will attract strict disciplinary action.
13. Reporting Time at the examination center is 09:30 AM. All the candidates should be in the examination hall on time, and late comers will not be permitted to enter the hall. Attendance will be recorded from 09:30 AM onwards.
14. Candidates must secure a minimum of 50% in Theory and 50% in Practical examinations separately to clear the university exam.
15. There is no revaluation. Only retotaling is permitted after payment of stipulated fee as per university regulations.
16. Candidates who successfully pass the University examination shall be awarded the Fellowship certificate in the respective specialty.

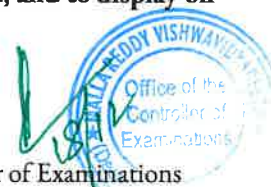
