This Notification is issued for registration of the candidates to appear for B.Sc Nursing (2025-26 Batch) First Semester University Examinations commencing from 31.01.2026.

#### Eligibility:

1. The First-year students of B.Sc Nursing admitted by Malla Reddy Vishwavidyapeeth during the academic year 2025-2026, whose admissions are approved by the University and completed study period and who are having 80% (Eighty Percentage) attendance in each of the subjects in both theory and practicals separately and passed internal assessment examinations with 50% (Fifty Percentage) marks.
2. The Communicative English shall be conducted as a college exam, and a minimum pass is 40% (Forty Percentage). Secured marks must be sent to the Controller of Examinations for inclusion in the marks sheet, but the marks are not included in calculating the SGPA.
3. The Cut-off date for the calculation of the attendance percentage and internal assessment marks of the candidates is 17.01.2026.
4. The uploading of the attendance percentage and internal assessment marks of the candidates is 18.01.2026.
5. The confirmation date for the uploaded attendance percentage and internal assessment marks of the candidates is 19.01.2026.
