#### Eligibility:

The First year students admitted by Malla Reddy Vishwavidyapeeth during the academic year 2025-2026 whose admissions are approved by the University and completed study period with a minimum of **80%** attendance in theory, and passed internal assessment examinations with a minimum of **50%** marks are eligible to write **MASTER OF PUBLIC HEALTH (MPH)** First Semester Examinations to be held in the month of January-2026.

3. The confirmation date for the uploaded attendance percentage and internal assessment marks of the candidates is **17.01.2026**.

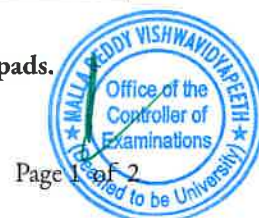
