4. The students need to submit a Signed Acknowledgement that they have gone through the last 3 years' dissertations in other dental universities and that their topic has not been worked upon in the specialty concerned to prevent duplication of dissertation topics.
5. The circulation should be displayed in the notifications of all colleges.
