This Notification is issued for registration of the candidates to appear for the Second Year MBBS (2024-25) Regular University Examinations commencing from 01.09.2026.

ELIGIBILITY:

The Second year students admitted by Malla Reddy Vishwavidyapeeth during the academic year (2024-25) whose admissions are approved by the University and completed study period, who are having **75%** attendance in each of the subjects, **80%** attendance in each practical/clinical posting and have passed internal assessment examinations with **50%** marks are eligible to write Second Year MBBS Examinations to be held in September 2026.

1. The Cut-off date for the calculation of the attendance percentage of the candidates is **12.08.2026**.
2. The uploading of the attendance percentage and internal assessment marks of the candidates is on or before **15.08.2026**.
3. The confirmation date for the uploaded attendance percentage and internal assessment marks of the candidates is **17.08.2026**.

Criteria for passing in a subject: A candidate shall obtain 50% marks in aggregate and 60:40 (minimum) or 40:60 (minimum) in University conducted examination separately in Theory and in Practical (practical includes; practical/clinical and viva voce) in order to be declared as passed in that subject.
