ELIGIBILITY:

1. The First year MDS students admitted by Malla Reddy Vishwavidyapeeth during the academic year (2025-26) whose admissions are approved by the University and completed study period, who are having **80%** attendance are eligible to write First Year University MDS Examinations to be held in August 2026.
2. The Cut-off date for the calculation of the attendance percentage of the candidates is **11.08.2026**.
3. The uploading of the attendance percentage and internal assessment marks of the candidates is on or before **12.08.2026**.
4. The confirmation date for the uploaded attendance percentage and internal assessment marks of the candidates is **13.08.2026**.
