ELIGIBILITY:

The First year students admitted by Malla Reddy Vishwavidyapeeth during the academic year (2024-25) whose admissions are approved by the University and completed study period, who are having **75%** attendance in each of the subjects, **75%** attendance in each practical/clinical posting and have passed internal assessment examinations with **50%** marks are eligible to write Second Year BDS Examinations to be held in September 2026.

1. The Cut-off date for the calculation of the attendance percentage of the candidates is **04.09.2026**.
2. The uploading of the attendance percentage and internal assessment marks of the candidates is on or before **05.09.2026**.
3. The confirmation date for the uploaded attendance percentage and internal assessment marks of the candidates is **07.09.2026**.
